A District Board of Revision

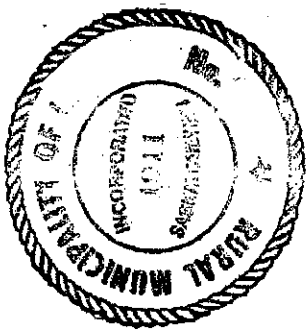
The Council of the Rural Municipality of _____ No. _____ in the Province of
Saskatchewan, enacts as follows:

1. **PURPOSE:**

The purpose of this bylaw is to enable the Council to enter into an agreement with ten other municipalities to create a District Board of Revision and to sign an Agreement attached hereto.

This bylaw becomes effective when all member municipalities have passed it by resolution of council. This agreement may be signed in counterparts and all shall be deemed on original instrument.

DISTRICT BOARD OF REVISION AGREEMENT

BETWEEN:

(Hereinafter referred to in the aggregate as the "municipalities")

WHEREAS, the municipalities have passed resolutions requesting to participate in the formation of a District Board of Revision:

THEREFORE, the municipalities agree as follows:

1. Up to ^{eleven} ~~eight~~ members shall be appointed to the District Board of Revision.
2. No more than three members shall sit on the Board of Revision at any one time. The Chairperson of the Board shall be designated by the members and may appoint panels of three members.
3. The Secretary of the District Board of Revision, in consultation with the Administrators of the municipalities, shall co-ordinate the activities of the Board of Revision and co-ordinate information between the councils of the municipalities.
4. The municipalities shall pass complimentary resolutions approving the appointments to the District Board of Revision and the amount of remuneration to be paid for their services.
5. The municipalities shall pass complimentary resolutions approving the appointment of a Secretary to the District Board of revision and the amount of remuneration to be paid for his/her services.
6. In the event of any dispute between the municipalities regarding appointments or remuneration, the matter shall be determined by a majority of the participating municipalities.
7. The Rural Municipality of No. shall pay for all expenses related to the operation of the District Board of Revision including the training its members, and recover the costs from the participating municipalities in an amount proportional to the time spent by the Board in hearing the appeals of the respective municipalities.

Appendix A

DISTRICT BOARD OF REVISION AGREEMENT

8. No municipality shall pay less than \$200.00 annually as its share of the cost for the operation of the District Board of Revision. This recognizes the costs of training and recruiting members of the Board.
9. Any municipality may withdraw from this Agreement by providing written notice prior to December 1st of any year. Such notice shall be delivered to the Administrators of the municipalities to this Agreement.
10. Additional municipalities wishing to become a party to this Agreement shall be required:

- (a) to obtain written approval of the originating municipalities prior to December 1st and
- (b) to provide in the first year of participation a fee equivalent to two times the annual fee stated in item 8 above (\$400.00)

This agreement may be executed in any number of counterparts with the same effect as if all parties had signed the same document. All counterparts shall be construed together, and shall constitute one and the same agreement.
